- 1/ The manufacturing allowances and butterfat yield factor used to compute the Class II, Class III, Class IV, and component prices in this announcement, as well as future computations of Class II, Class III, Class IV, and component prices factors, and Federal order minimum prices will use the revised manufacturing allowances and butterfat yield factor contained in the Interim Final Rule published in the Federal Register July 31, 2008 (73 FR 44617).
- 2/ Released May 21, 2010, using the formulas in the Interim Final Rule Dated July 31, 2008.
- 3/ The processor assessment is an obligation under the Fluid Milk Promotion Order (7 CFR §1160.101 et seq.). The Order requires that all persons who process and market commercially more than 3,000,000 pounds of fluid milk products in consumer-type packages in the 48 contiguous States and the District of Columbia on a monthly basis, excluding those fluid milk products delivered to the residence of a consumer, be assessed 20 cents per hundredweight on all marketings of such packaged fluid milk products during the month.
- 4/ Payment to the Transportation Credit Balancing Fund is a marketwide assessment pursuant to §1007.81 of the order. The assessment of \$0.30 per hundredweight is applied to the total pounds of Class I producer milk.
